

In the years of the pandemic, social isolation of seniors was never more apparent. CWAS faced difficult operational and financial challenges as Covid restrictions had to be followed. But through it all, CWAS remain committed to serving its seniors and beneficiaries and will continue to do so.

Refocus on What Really Matters

Early in 2022, the Board of Directors and the operating team jointly reviewed the charity's last 5 years of work and made a list of recommendations going forward.

Our strategic work plan for the next 5 years will strengthen connections

with beneficiaries and deepen partnerships with stakeholders and government agencies to fight social isolation of seniors in Singapore.

Over the year, CWAS welcomed more than 10 new Social Sector partners to our community through the relaunch of new versions of the Trishaw Ride and Virtual Reality Ride services. Through this and other initiatives, we will continue to improve the work we do and serve with our best.

Since our inception in May 2017, CWAS has provided 11,000 trishaw rides to various beneficiary groups, such as seniors from nursing homes and daycare centres, and people with disabilities.



Evolve to Match the Changing Narrative of Senior Social Isolation

By 2030, almost 1 in 4 Singaporeans will be over 65, according to Prime Minister Lee Hsien Loong in his speech at the book launch of 'Singapore Ageing: Issues and Challenges Ahead' in NUS in April this year. As a result, many lonely seniors may fall outside of traditional focus areas such as rental flats and eldercare facilities.

CWAS is committed to ensuring our seniors are not left behind. Some initiatives that we have taken to enhance our services include the relocation of our trishaws to more publicly accessible places such as Gardens by The Bay, Jurong Lake Garden and Passion Wave @Marina Bay. In response to feedback from our partners, we have extended our trishaw ride events to 4 hours to increase social interaction time and provide a better overall experience for our beneficiaries. And for our less ambulant seniors, we launched a pilot programme to provide them with virtual reality (VR) rides using VR headsets by Oculus.

CEQ's Message

"The only constant in life is Change" – Heraclitus

Change is the key word in 2022 as Singapore leaves a year of disruptions. Many changes around the world and in Singapore are permanent and have changed the way we work. Cycling Without Age Singapore (CWAS) has made organisational changes with a keen focus on upgrading staff knowledge and skills. We have also reolcated some of our trishaws to more accessible public service locations. Our popular 30-minute trishaw rides are now available in 4-hour events to enhance engagement and social interaction time with seniors.



On the infrastructure front, we have evaluated our operations and prioritised a list of digitalisation opportunities for the new year like the VR rides. I believe this has helped us develop stronger capabilities as a charity to better serve our seniors in the Singapore community.

Recognising Our Ability to Make an Impact

Rather than counting the number of trishaw rides to achieve our operational goals, we are now moving to a more meaningful concept of 'Happy Hours' in the new year. In this approach, we will focus on ensuring quality time is spent with our seniors.

We will also monitor all impact measurements such as our Happiness Index to ensure beneficiaries continue to enjoy our service sets.

Leading the Charge in Serving

In 2022, we launched our Virtual Reality Ride service using the Oculus virtual reality headsets to support our less ambulant seniors in the community who are not able to ride in our trishaws. We expect to see at least 20 social sector partners working with us next year on our virtual rides as these less mobile seniors are among those they serve. We hope to be able to reach 1.000 seniors in this outreach.

In our relocation of the trishaws to public service locations, we saw new social sector partners reaching out to us to serve seniors under their care. Our plan is to add a new service location in the East in the coming months.

Preparing for the Future

I am honoured to lead a growing team that has triumphed over challenging episodes in 2022. With the changes and plans I have outlined, I believe CWAS is in a better position now to serve. We will continue to anchor ourselves as a valuable component in Singapore's fight against social isolation among seniors with new services and service locations.



My confidence in this belief comes from the ongoing strong support from our board of directors, social sector partners, funding partners, government agencies, volunteers, donors, and corporate stakeholders. Our seniors will continue to benefit from your generous assistance in the years to come.

Charity Transparency Awards

First launched in 2015, the Charity Transparency Framework (CTF) aimed to improve transparency and accountability in the charity sector. In Minister Edwin Tong's speech during the 2022 Charity Transparency and Governance Awards ceremony, he said that

"The aim is to ensure that charities continue to adhere to principles of good and accountability, while governance making sure that the charities are not overly burdened by administrative requirements that prevent them from carrying out the good work that they do more and allowing them to work effectively for their charitable causes,".



Partners Recognition

In 2022, a record breaking 85 charities received the Charity Transparency Award for providing comprehensive information regarding their funding in their annual reports, financial statements, governance evaluation checklists and websites.

On 9 November, 2022, we were honoured to be presented with the Charity Transparency Award for our exemplary disclosure practices. We have successfully implemented the COC transparency framework and governance standards, which is truly inspiring considering the presence of over 2,300 charities in Singapore.

New Service Locations

Since the inception in 2017, the trishaws have been deployed all over the island within various eldercare facilities and day centres.

This year, we included new service locations in public places such as Gardens by the Bay, Jurong Lake Gardens and Passion Wave @Marina Bay in an effort to reach more seniors in the community and optimise the use of our trishaws.

Empowerment Programme

In 2022, our longevity and empowerment programme for volunteers aged 50 and above remains a top priority. With funding from The Council for Third Age, we sought to involve and train senior volunteers to serve other seniors. The training encompasses trishaw piloting, bike marshalling, game mastery, and virtual reality ambassadorship.

Virtual Reality Ride Service

Last year, a pilot with Ren Ci Nursing Home Ang Mo Kio and SMU volunteers was conducted for over 40 seniors and the results were positive. In 2022, the plan was to open last year's single location pilot to an island wide scope so that new Social Service Agency Partners could be included. Extra focus for this more extensive pilot was given to deployment of our Oculus headsets for less-ambulant seniors with mobility challenges.

Our plan to launch the Virtual Realty Ride Service moved twice and was finally launched in Quarter 4 of 2022. Interest was high among the nursing homes as their seniors had not been out of the homes for a long time.

For the remaining quarter, we dedicated our efforts to training and distributing Oculus Headsets to our SSA Partners. We were delighted to have successfully deployed them to a minimum of 8 homes and trained over 15% of our targeted volunteer count, making significant progress towards our goals.

Fundraising - Cycle For Good 2022

Cycle for Good has been the annual flagship fundraising event for Cycling Without Age Singapore (CWAS) since 2020. It started as a ground-up initiative by a few supporters putting in the efforts to tell others about the good work done in this charity and asking for donations to support. These outreach elements from the first run continued to be a big part of the DNA for the following editions.

In 2022, this campaign was designed to raise funds to support engagement of 750 new beneficiaries as well as train 100 new volunteers. It included a virtual ride for cyclist fundraisers as well as a special physical ride led by a special supporter.

Cycle for Good 2022 - Virtual Ride attracted 61 cyclist fundraisers and 11 teams who raised S\$98,086 and these supporters rode thousands of kilometres around the island over 10 weeks.

Conduct Of Affairs

The Board of Directors ('Board') conducts its affairs as set out in the CWAS Constitution and the Terms of Reference.

The board provides guidance to the Chief Executive Officer in overseeing the smooth day to day operations of CWAS. The board also provides consultative, networking and resource support to the CWAS Management Team to ensure smooth service delivery, compliance with all relevant laws and regulations and sustainability of CWAS.

To assist the Board in the execution of its duties, the Board has delegated specific functions to various committees. These committees operate within the Terms of Reference approved by the board.

The Board 's decision and approval is required for the following matters:

- Corporate and services strategies and policies
- Annual Budget
- Strategic Alliances
- Annual Report and Accounts
- Interested person transactions and matters involving conflict of interest for a director
- Any material and significant matters.

The Board meets at least 6 times a year and more than half of the board must be present for proceedings to be valid. The board can also participate in decision making via electronic communications and in writing. The number of meetings attended by the board during the financial year can be found in which page of the report.

Appointment As Director Of The Board

All potential Directors of the Board will be invited to first serve in one of CWAS's management committees. They are also required to attend one board meeting as observers before they can co-opted as a Board Director. This is to familiarise them with strategic directions and operations of the organisation, including governance framework and Board responsibilities.

Besides briefing at meetings and email circulars, Board Directors are encouraged to attend training programmes when necessary, to keep appraised relevant new laws, regulations and changes in the charity landscape.

Board of Directors Composition and Membership

All directors of the board are independent and do not receive any remuneration for the services to the organisation, with the exception of the CEO.

New directors are selected based on:

- Knowledge of and/or specific skill sets
- Management Experience
- Diversity
- Alignment to CWAS's vision, mission and core values

All directors shall be appointed by the Chairman of the Board. Each director shall hold office for an initial term of three (3) years, renewable for further three (3) years period by way of an Ordinary Resolution at a general meeting.

Risk Management and Internal Control

The Board has overall responsibility for the charity's key risks to safeguard the charity's interests and assets. They have an oversight function, ensuring that processes are in place, and are adequate and effective in fulfilling the mission of CWAS.

The audit committee assists the board in providing risk management oversight while the ownership of day to day management and monitoring of existing internal control systems are delegated to the management team.

Summary of Financial Performance

Major Financial Transactions

The total expenditure for the past 12 months ending 31 December 2022 was \$474,317. The expenses are not comparable to last year's expenditure as last year's reporting was for 8 months only. However, the charity did not note any significant increase in expenditure. The fundraising and and donation income of \$175,227 was lower than budgeted due to similar virtual cycling campaigns which did not draw as many donors as expected.


For the unrestricted funds, the total funds in our reserve position for the year ending 31 December 2022 is \$348,231 as compared to previous year which was \$322,310.

The reserve ratio slightly declined as the charity builds up a new team and a self-sustaining funding model. The charity is looking forward to a more robust financial standing ahead with new strategic direction. The reserves will be built up slowly as the charity focuses on new infrastructure and development strategies.

From the total donations of \$175,227, \$117,821 was tax deductible and \$57,406 was non tax deductible.

The fundraising income for the year was \$170,558 and corresponding fundraising expenses of \$37,252. The fundraising efficiency ratio of 21.8% is in compliance with the 30/70 efficiency rule set by the Commissioner Of Charities.
